1. *General Education*. Led college through major revision of undergraduate general education requirements: "The McDaniel Plan," unanimously approved by the faculty in May 2005, features a strengthened program of First Year Seminars and new programs in Writing in the Disciplines, Sophomore Interdisciplinary Studies (team-taught and collaboratively taught courses), Global Citizenship (including international and multicultural courses and foreign languages), and lab-based Scientific Inquiry. Developed team-based approach to first-year program through "First Year Team," coordinating Academic Affairs and Student Affairs.

2. *Program Development*. Established new major in Environmental Policy and Science and new minors in Africana Studies, Cognitive Science, and Latino and Latin American Studies. In Graduate and Professional Studies, established Center for the Study of Aging and added M.S. programs in Gerontology and TESOL (Teaching English to Speakers of Other Languages) and certificates in Gerontology in Global Enterprise.

3. *Faculty Recruitment*. Implemented substantial increases in the size of the faculty across the undergraduate and graduate programs, including 12 new tenure-track positions and 7 lecturer positions,

and supervised successful searches. Revised faculty search guidelines and introduced measures to increase applicant diversity, resulting in an increase in appointments from underrepresented groups. 4. *Faculty Development*. Established Distinguished Scholar Program, with semester course releases for faculty for scholarly work. Substantially increased annual funds for Professional Travel (currently at \$1,000 each) and for Faculty Development Grants (currently at \$35,000). With the support of a grant from the Mellon Foundation, established the McDaniel College Center for Faculty Excellence, providing programmatic support for faculty at all stages of professional life. Established positions of Director of Center for Faculty Excellence and Director of College Writing.

5. *Assessment and Accreditation*. Established new Academic Assessment Committee, which developed a general education assessment program. Strengthened departmental assessment programs. Established the Office of Institutional Research and Assessment. Led academic dimension of McDaniel's five-year Periodic Review Report (2008), which received unconditional approval by Middle States.

6. *Budget and Finance*. Responsible for the academic budget (with salaries, approximately one half of \$55.4), working through the Budget Committee. Engaged in response to projected budget shortfalls in fiscal 09 and 10, resulting in development of balanced budgets.

7. *Grants and Gifts.* Established the Office of Academic and Government Grants with a full-time faculty grants officer and increased grant proposal and funding (28 proposals in 2007-8, resulting in 15 awards for almost \$400,000). Developed or assisted with successful proposals to the Mellon Foundation, Jesse Ball duPont Fund, AmeriCorp*VISTA, and Fulbright programs. Collaborated with regional liberal arts colleges to win two grants from the Teagle Foundation.

8. *Service Learning*. Established formal service learning program and Center for Community Outreach and Service, with workshops and logistical support to assist faculty in course development. Efforts supported by grants from AmeriCorps*VISTA and Bringing Theory to Practice. College playing a leadership role in establishment of a Maryland Campus Compact.

9. *International Education*. Established the International Programs Office and appointed first full-time Director of International and Off-Campus Study. Student participation in study abroad has risen to 33%, with marked increase in semester programs and faculty-led Jan Term programs. Supervised branch campus in Hungary, McDaniel College Budapest, establishing it as premier destination for study abroad students.

10. *Technology*. Appointed college's first full-time Chief Information Officer in 2006, with strong development and improvement in information technology, including infrastructure and equipment, wireless, and security and contingency plans. Established new center for instructional technology, increased use of Blackboard course management system, and developed new programs to help faculty incorporate technology into their teaching. Increased delivery of online instruction in graduate programs, whole course or "hybrid."
